h) any causes for action for duly maintaining and defending the IP Rights at the risk and cost and expense of the Buyer against any third party infringements or attempted infringements, including defence or settlement of the Claim and to bear the risk and costs and expenses of the maintenance and defences or settlements of the Claims; and

i) all rights to collect royalties and other payments under or on account of the Patents and/or any item in any of the foregoing categories a) through g);

(a)-i) collectively, the "Patent Rights").
