## WAIVER AND RELEASE OF LIEN


WHEREAS, Sunstein Kann Murphy & Timbers LLP ("SKM&T") is owed certain fees for services it has performed for SurIDX, Inc. ("SurIDX");

WHEREAS, SurIDX has secured a commitment to receive a loan of additional funds to continue its essential operations, and a condition of the lender making such loan is that SKM&T release all liens it holds against the assets of SurIDX;

NOW THEREFORE, SKM&T, for good and valuable consideration, the receipt whereof is hereby acknowledged, hereby waives all claims to any secured or priority interests and liens it may hold against any assets of SurIDX, whether under and by virtue of the laws of the Commonwealth of Massachusetts relating to attorneys' liens or otherwise.

SKM&T hereby grants to SurIDX and/or its agents the right to make all UCC filings with the Massachusetts Secretary of the Commonwealth and all filings with the United States Patent and Trademark Office as it may reasonably determine are necessary to terminate any existing liens or assignments of interest SKM&T may have with respect to its assets. (To the extent necessary, this writing shall constitute a grant of a power of attorney to the officers of SurIDX for such limited purpose.) Upon execution and filing of such documents with the appropriate government offices, any obligations owed to SKM&T by SurIDX shall remain outstanding as an unsecured obligation of SurIDX owed to SKM&T.
