The Assignor covenants that it has full rights and power to enter into this Assignment Agreement and agrees that it will communicate to the Assignee or its representative, all facts known to it respecting the Invention, whenever requested, and that it will provide access to personnel to testify in any legal proceeding, and that it will have its authorized signatory/ies sign all lawful papers, execute all division, continuation and reissue applications, and make all rightful oaths, and generally do everything possible to aid the Assignee, its successors, assigns, and nominees, to obtain and enforce proper patent protection for the Invention in said country.


