ASSIGNMENT OF PATENT RIGHTS

This Assignment of Patent Rights ("Assignment") is made effective as of the 19 day of July, 2011 (the "Effective Time") between American Prosthetic Components, Inc., a Wisconsin corporation ("APC"), Michael Curtis, an individual ("Curtis") and collectively with APC, "Assignors") in favor of American Prosthetic Components, LLC, a Delaware limited liability company ("Assignee"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Asset Purchase Agreement dated July 30, 2011 between APC and Assignee (the "Purchase Agreement").

WHEREAS, Assignors, respectively, are the owners of the entire right, title and interest in and to the U.S. patents and patent applications listed on Schedule A, attached hereto and made a part hereof, the inventions described in such patents and patent applications, all improvements thereto, and other proprietary products (which are not the subject of patent filings) (the "Inventions"); and

WHEREAS, Assignors and Assignee entered into the Purchase Agreement and related documents whereby Assignors agreed to assign certain of its intellectual property assets, including, without limitation, the entire right, title and interest in and to the Inventions, to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby freely acknowledged, and intending to be legally bound, as of the Effective Time said Assignors sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, to said Assignee, the entire right, title and interest of the Assignors, throughout the world, in and to the Inventions and any and all continuations, divisions, and renewals of and substitutes for said Inventions, all priority rights under the International Convention, and in, to and under any and all patents which may be granted on or as a result thereof in the United States and its possessions and territories and in all other countries, and any reissue or reissues or extension or extensions of said patents, and the right to sue and recover damages for any and all infringements and unauthorized uses of the above mentioned rights, the same to be held and enjoyed by said Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which said patents respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by Assignors had this assignment, sale and transfer not been made.

In the event that any of the Assignors or the Assignee becomes aware after the date hereof of any intellectual property assets owned by any of the Assignors that would, if properly scheduled, have been considered Inventions as of the date hereof, then Assignee shall be entitled to add such items to Schedule A and such items shall be deemed to be "Inventions" hereunder for all purposes of this Assignment.

The undersigned Assignors hereby covenant that each of them possesses the full right to convey the entire interest herein assigned, and that Assignors have not executed

and will not execute any agreement in conflict herewith, and further covenant and agree that Assignors will each time request is made and without undue delay, execute and deliver all such papers as may be reasonably necessary or reasonably desirable to perfect the title to said Inventions in said Assignee, its successors, assigns, nominees, or legal representatives, and agrees to communicate to said Assignee or to its nominee all facts known to Assignors respecting said Inventions, to testify in any legal proceedings, to sign all lawful papers, to execute all disclaimers and divisional, continuing, and reissue applications, to make all rightful oaths, and generally to do everything commercially reasonable to aid said Assignee, its successors, assigns, nominees and legal representatives to obtain and enforce for its own benefit proper patent protection for said Inventions in the United States and its possessions and territories and in all other countries;

Assignors hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue to said Assignee, the entire right, title and interest, in and to any and all Inventions, including any and all patents of the United States which may be issued and granted on or as a result of the application aforesaid, in accordance with the terms of this Assignment.


