ASSIGNMENT OF PATENT RIGHTS

WHEREAS I, Donald R. Smith, an individual residing in the Town of Strathmore, in the Province of Alberta, and having an address at Box 9, Site 17, RR2 Strathmore, Alberta, T1P 1K5 (hereinafter the "Assignor") has invented and am the sole inventor of an invention entitled:

RECIRCULATION BIN FOR DRILL TAILINGS HAVING DEFLECTOR MEANS, AND A DRILL TAILINGS HANDLING APPARATUS

for which US and Canadian patent applications as identified in Schedule "A" hereto have been filed in the respective United States Patent and Trade-mark Office and Canadian Intellectual Property Office, respectively (hereinafter the "Invention");

NOW THEREFORE, in consideration of the foregoing premises, and the sum of one dollar (\$1.00) and for other good and valuable consideration paid to the Assignor by Assignee the receipt and sufficiency of which is hereby acknowledged by me the Assignor, I as Assignor hereby sell, assign and transfer absolutely to the Assignee all of my full right, title and interest that I am possessed of in and to: (a) the Invention worldwide; (b) any and all patent applications for the Invention in all countries and jurisdictions and under all conventions and treaties, including those listed in Schedule "A", and including the right to claim for any and all applications any priority rights to which such applications are entitled under conventions, treaties or otherwise, and all divisions, extensions, continuations, continuations-in-parts, provisionals, non-provisionals, substitutions and renewals thereof; (c) all letters patent which may be granted therefor in any and all countries and jurisdictions, and any renewals, reissues, re-examinations or extensions of the letters patent, and (d) the exclusive right to bring or participate in any proceeding for infringement or any other actionable right under all of the

foregoing and to receive all remedies that arise therefrom, to the end of the term for which said letters Patent may be granted, as fully and entirely as the same would have been held by me had this Assignment not been made.

I, as Assignor, hereby authorize and request the patent offices in all countries and jurisdictions to issue any and all of the letters patent to any entity to whom the Assignee may assign its part interest in the Invention. Further, I agree that I will communicate to the Assignee or its representatives any facts known to me respecting the Invention, and testify in any legal proceeding, sign all lawful papers, execute all papers relating to all patent applications including all divisional, continuation, continuation-in-part, extension, renewal, provisional, non-provisional or substitute thereof, and the letters patent including any renewal, re-examination, extension and reissue of said letters Patent, execute all necessary assignment papers to cause any and all of said Letters patent to be issued, make all rightful oaths, and, generally do everything possible to aid the Assignee, its respective successors and assigns, to obtain and enforce rights which the Assignee has become possessed of in regard to the Invention in all countries and jurisdictions.

I, the Assignor, hereby authorize the firm of Gowling Lafleur Henderson LLP to correct any errors in this assignment or to insert any further identification or other information necessary or desirable to make this assignment suitable for recordal in any country.




