 - (d) all extensions, renewals, reissues, divisions, continuations and continuations-in-part (or their legal equivalents) of any applications or Letters Patent referred to above.


2. I authorize and request the Commissioner of Patents and Trademarks of the United States, to issue to Assignee all Letters Patent or similar legal protection for the Invention.
