

ASSIGNOR authorizes and requests the United States Commissioner of Patents and Trademarks (or similar official) to issue any and all United States Letters Patent resulting from the Patent Assets or any divisions, reissues, continuations, renewals, extensions, substitutes or re-examinations thereof to ASSIGNEE as assignee of ASSIGNOR's interest therein.
