b) "Assignee" means **TRAVELPRO INTERNATIONAL INC.**, incorporated in State of Delaware, having a place of business 700 Banyan Trail, Boca Raton, FL 33431, USA, including its successors and assigns.

c) "Invention" means an invention made by the Assignor and entitled, **HANDLE FOR LUGGAGE** and having Application No. **61/407,971**, filed **October 29, 2010**.

d) "Rights to the Invention" means, without limitation, all rights, titles, interests and claims of any nature in and to:

- i) the Invention for Canada, the United States of America and all other foreign jurisdictions;
- ii) all Patent Applications for the Invention for Canada, the United States of America and all other foreign jurisdictions ("Patent Applications");
- iii) all Letters Patent that may be obtained for the Patent Applications ("Issued Patents");
- iv) all continuations, continuations-in-part, re-examinations, reissues, requests for continued examination (RCE) and divisions of the Patent Applications and/or Issued Patents; and,
- v) the right to claim priority under International Convention and/or Treaties for the Patent Applications and/or Issued Patents.

**2. BACKGROUND**

a) The Assignee wishes to acquire the Rights to the Invention from the Assignors.

d) Assignors hereby authorize and request the Commissioner of Patents (or the equivalent) for any jurisdictions where Assignee files applications for the invention, to issue Letters Patent in that jurisdiction for the Invention to the Assignee, for the Assignee's sole use and benefit, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by the Assignors had this Assignment not been made.

e) Assignors hereby undertake without liability at any time upon request to do everything legally possible to assist the Assignee in the filing and prosecution of any patent application relating to the Invention in any jurisdiction, including to sign such documents and do such things as may be required to give effective legal and registered title of the Assignee to the Invention in any jurisdiction, and to testify in any legal proceeding, all without further consideration but at the expense of the Assignee.
