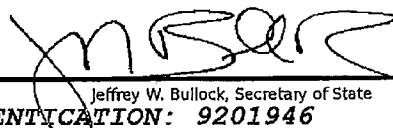

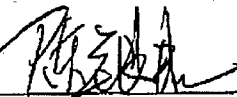
The name of this corporation is DunAn Microstag, Inc.
