The undersigned acknowledge and agree that the obligation to make this assignment existed at the time the assigned subject matter was conceived.

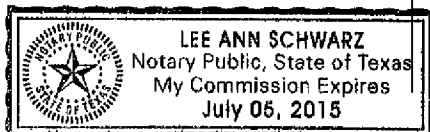
