
WHEREAS, Assignee desires to acquire all rights, titles, and interests in and to said Patent Application;

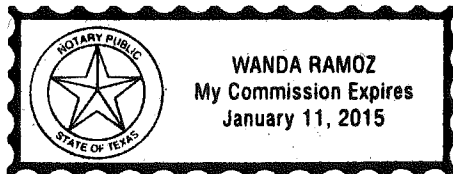
