Be it also known that, for good and valuable consideration, the receipt of which from Assignee is hereby acknowledged, Assignor (Tokyo Denpa) hereby sells and assigns to Stanley Electric a half (17.5%) of its entire right, title, and interest in the '207 Patent, and hereby sells and assigns to Tohoku University the remaining half (17.5%) of its entire right, title, and interest in the '207 Patent, to be held and enjoyed by Staley Electric and Tohoku University, their successors, and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made.
