And said **ASSIGNORS** for said consideration hereby covenant and agree that the said

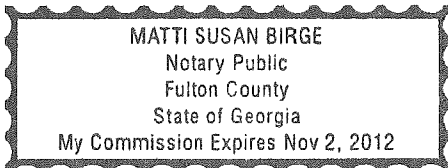
