infringement and to collect for all past, present and future damages; and the Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and any officials of any other countries whose duty it is to issue patents or register industrial designs on applications as aforesaid, to issue all patents for said design and corresponding industrial design registrations to Assignee in accordance with the terms of this assignment;

AND the Assignor further covenants and agrees that it will communicate to Assignee any facts known to it respecting said design, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said design in all countries.
