PATENT ASSIGNMENT

WHEREAS, Craig Anthony Nazzer ("NAZZER"), a citizen of New Zealand residing at 37 Messenger Terrace Oakura, Taranaki, New Zealand, and Prime Services, Ltd. ("PRIME SERVICES LTD"), a New Zealand limited company, having a registered office at 7 Liardet Street, New Plymouth, New Zealand having between them acquired all rights, title, and interest in and to the inventions identified in Exhibit A, attached hereto, either individually or jointly, as a sole inventor or by way of a patent assignment, and now individually or jointly own all associated pending patent applications and granted patents based upon said inventions and any and all patent rights therein;

WHEREAS, PRIME SERVICES TRUST ("THE TRUST") is a Trading Trust established in New Zealand by NAZZER as settlor with the named trustees, Prime Services Trustee Limited and VBW Trustees No. 2 Limited ("THE TRUSTEES"), on February 28, 2011, wherein THE TRUST has a distribution date of March 31st 2090 or any earlier date chosen by THE TRUSTEES and the Trust Deed for THE TRUST is shown in Exhibit B; and

WHEREAS both NAZZER and PRIME SERVICES LTD desire the transfer and assignment of all his/its rights, title, and interest in and to each said invention identified in Exhibit A to THE TRUSTEES as trustees of THE TRUST, and to the extent such rights are held individually and/or jointly between them.

NOW, THEREFORE, both NAZZER and PRIME SERVICES LTD. intending to be legally bound, and for good and valuable consideration for such transfer of rights, the receipt and sufficiency of which is hereby acknowledged, agree as follows:

NAZZER and PRIME SERVICES LTD do hereby sell, assign, and transfer to THE TRUSTEES as trustees of THE TRUST any and all rights, title and interest in and to the inventions identified in Exhibit A together with any and all patents and patent applications identified in Exhibit A, and any patent applications or patents which may be issued or granted on

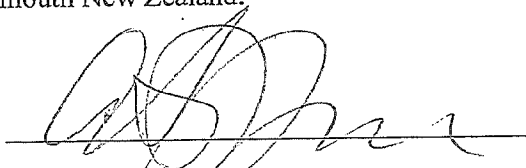
said inventions throughout the world. The rights of THE TRUSTEES as trustees of THE TRUST in said inventions include the right to file patent applications and obtain patents, utility models, industrial models and designs for each said invention throughout the world and also includes all rights to sue others for past, present and future acts of infringement and to retain all revenues received from others for past acts of infringement.

NAZZER and PRIME SERVICES LTD hereby agree to sign lawful papers, execute divisional, continuation, continuation in part and reissue applications, make rightful oaths, and generally do everything possible to aid THE TRUST and THE TRUSTEES as trustees of THE TRUST, its successors, assigns and nominees, to obtain and enforce patent protection for said inventions in all countries named in Exhibit A.

NAZZER and PRIME SERVICES LTD hereby authorize and request the appropriate officers in all THE IP OFFICES to issue any and all patents granted upon the applications identified in Exhibit A to THE TRUSTEES as trustees of THE TRUST for the sole use and enjoyment of THE TRUSTEES as trustees of THE TRUST and to record this Assignment against any and all issued patents and pending patent applications identified in Exhibit A, and future patent applications or patents that may be granted upon the inventions.

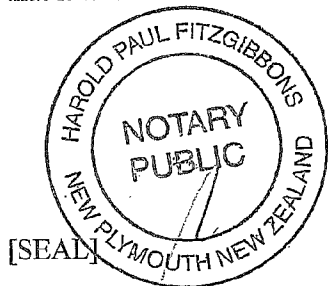

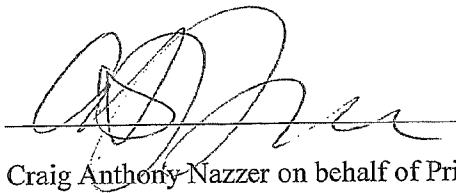

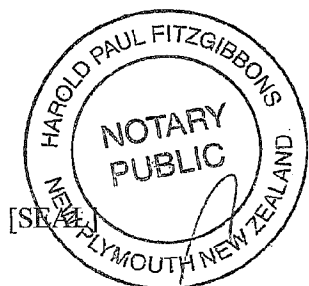
