TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of October 22, 2013 ("Release"), is made by **WELLS FARGO BANK** (including as successor-by-merger to **WACHOVIA BANK**), **NATIONAL ASSOCIATION**, as Collateral Agent ("Collateral Agent"), in favor of **INTERFACE, INC.**, a Georgia corporation, and the other Grantors under the IP Security Agreements (defined herein) (each a "Grantor", and collectively the "Grantors").

WHEREAS, pursuant to that certain Second Amended and Restated Pledge and Security Agreement dated as of June 24, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, together with any predecessor Security Agreement, the "Security Agreement") by and among the Grantors and Collateral Agent, and the Intellectual Property Security Agreement dated as of June 24, 2011 ("2011 IP Security Agreement"), the Intellectual Property Security Agreement dated as of February 1, 2010 ("2010 IP Security Agreement"), and the Intellectual Property Security Agreement dated as of May 14, 2009 ("2009 IP Security Agreement", together with the 2011 IP Security Agreement, 2010 IP Security Agreement, and the Existing IP Security Agreements (defined in the 2010 IP Security Agreement) and assignments of Existing IP Security Agreements, each referenced by recordation information on the attached Schedule A, the "IP Security Agreements") each by and among the Grantors and Collateral Agent, Grantors granted to the Collateral Agent, for the benefit of the Lenders, a security interest in all of Grantors' Collateral (as defined in the 2011 IP Security Agreement), Patent Collateral, Trademark Collateral, and Copyright Collateral (collectively, "IP Collateral").

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Lenders, and Grantors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or IP Security Agreements.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Lenders, hereby:

(a) absolutely, unconditionally and irrevocably terminates the IP Security Agreements, and any other agreement under which Grantors have granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the IP Collateral;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release with the U.S. Patent and Trademark Office and U.S. Copyright Office at Grantors' expense.

SECTION 3. Further Assurances. Collateral Agent, at Grantors' expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the IP Collateral, Collateral Agent will, at Grantors' expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
