## ASSIGNMENT

This Assignment is made and entered into by and between GIANPIETRO BENEDETTI, residing at Via San Michele, 36, Tricesimo, I-33019, IT, and PAOLO BOBIG, residing at Via Mazzini, 17, San Canzian d'Isonzo, I-34075, IT, (collectively hereinafter "INVENTORS"), and DANIELI & C. 2. ASSIGNEE is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to ASSIGNEE in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.


