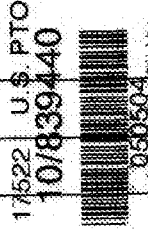

ASSIGNMENT

WHEREAS, I, Robert J. Nix residing at 1 Westbrook Court, Algonquin, Illinois 60102, invented certain new and useful improvements in **DUAL MOTOR STRAPPER**, and have executed an application for United States Letters Patent, and

WHEREAS, **ILLINOIS TOOL WORKS INC.**, a corporation organized and existing under the laws of the State of Delaware, having its principal place of business at 3600 West Lake Avenue, Glenview, Cook County, Illinois 60025, is desirous of acquiring the entire right, title, and interest in and to said invention, said application, and in to and under all Letters Patent of the United States and foreign countries that may be granted therefor;

Nix, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over to and unto said **ILLINOIS TOOL WORKS INC.**, its successors and assigns, for, within and throughout the United States and the territories thereof, and all foreign countries, the entire right, title and interest in and to said invention, and in, to and under said application, and all Letters Patent of the United States and foreign countries that may be granted for said invention and improvements, including divisions, reissues, subdivisions, continuations and prolongations of such applications and Letters Patent, to have and to hold for the sole and exclusive use and benefit of said **ILLINOIS TOOL WORKS INC.**, its successors and assigns, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issue, and further, including the right to **ILLINOIS TOOL WORKS INC.**, to file in its name applications for Letters Patent to said improvements in any country or countries foreign to the United States including the full right to claim for any such

applications the priority benefits of the International Convention for the Protection of Industrial Property and other priority conferring treaties, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.

I do hereby covenant and agree, for myself, my heirs and my legal representatives, that I will assist said **ILLINOIS TOOL WORKS INC.**, in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that said **ILLINOIS TOOL WORKS INC.**, may elect to make covering the invention herein identified, as hereinbefore set forth; in vesting in said **ILLINOIS TOOL WORKS INC.**, like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that I will execute and deliver to said **ILLINOIS TOOL WORKS INC.**, any and all additional papers that may be requested by said **ILLINOIS TOOL WORKS INC.** to fully carry out the terms of this assignment.

And I do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to application aforesaid, or for said invention, to said **ILLINOIS TOOL WORKS INC.**, its successors and assigns in accordance with this assignment.

And I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.
