NOW, THEREFORE, to dispel any uncertainty and prevent any future third parties from attempting to mimic said meritless claims, NET NAVIGATION and PACKET Q agree that PACKET Q has never had any right, title and interest in the Patents and that if it now has, or at any time ever did have, any right, title and interest to the Patents, PACKET Q hereby sells, assigns, transfers and sets over to NET NAVIGATION *nunc pro tunc*, any and all such rights,

title, and interest that PACKET Q owns or controls in and to the Patents, if any, which shall be understood to include all patents, all present and future divisions, continuations, reissues, reexaminations and all claims, demands, or causes of action that PACKET Q has or might have by reason of any infringement of any of the foregoing prior to the effective date of this assignment, including all rights to sue and collect damages for all past, present and future infringement and all lost profits resulting therefrom.
