ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.

ASSIGNOR HEREBY GRANTS to the law firm of **Butzel Long, counsel for ASSIGNEE**, the power and authority to insert into this Assignment any further identification necessary or desirable to comply with the rules of the U.S. Patent Office for recordation of this Assignment.

ASSIGNOR UNDERSTANDS AND AGREES that the attorneys and agents of the **Butzel Long** law firm represent the interests of the ASSIGNEE and do not personally represent ASSIGNOR OR ASSIGNOR's legal interests. Further ASSIGNOR acknowledges that the Butzel Long attorneys and agents do not provide legal advice to ASSIGNOR with respect to this Assignment and ASSIGNOR acknowledges its right to seek its own independent legal counsel.
