CONFIRMATION OF ASSIGNMENT OF PATENTS

PARTIES

2. **Ipower Australia Pty Ltd** ACN 123 597 437 of Unit 2, 246 Maitland Road, Mayfield NSW 2304, Australia (the **Assignee**)

RECITALS

- A. The Assignor has assigned to the Assignee all the Assignor's right, title and interest in and to the patents listed in the Schedule (the **Patents**) pursuant to a Deed of Assignment between the parties dated 16 June 2011 (**Effective Date**).
- B. The parties intend for the Assignee to hold the entire right, title and interest in and to the Patents including the right to apply for corresponding intellectual property rights in any country or region worldwide (the **Territory**) on and from the Effective Date.

OPERATIVE PROVISIONS

1. The Assignor hereby confirms that it has assigned to the Assignee to hold absolutely on and from the Effective Date:
 - (a) the entire right, title and interest in and to the Patents without geographical limit including the benefit of all rights arising from them;
 - (b) all corresponding rights obtained in the Territory in respect of the Patents and the inventions that are the subject of the Patents (the **Inventions**);
 - (c) all rights, powers, liberties and immunities arising from any rights granted in relation to the Patents and Inventions; and
 - (d) all right, title and interest in documents and materials relevant to applications for the Patents.
2. To the extent that the confirmation of assignment referred to in clause 1 is or is held to be ineffective, invalid or unenforceable, and for the avoidance of doubt generally, the Assignor hereby assigns to the Assignee all rights and benefits referred to in clause 1 in respect of the Patents and Inventions.
3. The Assignor agrees to do all acts and execute all documents necessary or desirable for further assuring the right, title and interest of the Assignee to the Patents.
4. This Deed may be executed by any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, is an original, and all of which, when taken together, are one and the same agreement.
5. The rights provided in this Deed will enure for the benefit of each party's successors and assigns.

6. This Deed is governed by and must be construed according to the laws of New South Wales, Australia.




