## PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (this "Patent Assignment"), effective as of November 1, 2013, (the "Effective Date") is made by and between:

WHEREAS, Assignee desires to accept from the Assignor the assignment and transfer of all of such Assignor's legal interest in and to the Patents and Inventions.

### CONSIDERATION:

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, each intending to be legally bound, do hereby agree as follows:

1. The foregoing recitals are hereby made a part of this Agreement.
2. Assignment. Assignor hereby assigns and transfers to the Assignee, its successors and assigns, and the Assignee hereby accepts the transfer and assignment of, any and all of the Assignor's legal interest in and to the Patents and Inventions including, without limitation, any application claiming priority therefrom, any provisional, non-provisionals, divisions, continuations or continuations-in-part thereof, re-examinations and the inventions therein disclosed, and any improvements thereon, and any patent or patents that may be issued or reissued thereon, and Assignor hereby authorizes and requests the Commissioner for Patents to issue any letters patents thereon and reissues thereof unto Assignee, its successors and assigns, and Assignor hereby authorizes Assignee, its successors and assigns, to file in its own name applications for patents in foreign countries in connection with the inventions thereby transferred, under the International Convention claiming priority to the Patents and Inventions or otherwise, and to secure in its own name the patent or patents issued thereon.
3. Further Assurances. For the above consideration, Assignor agrees promptly upon request of Assignee, his successor or assigns, to execute and deliver without further compensation any additional papers and make all rightful oaths, and all other acts which may be necessary in connection with the Patents and Inventions, and in connection with any other United States or foreign applications that may be filed in connection with the Patents and

Inventions, and with improvements thereon, and in connection with any patents issued or reissued thereon to secure, obtain or enforce proper patent protection for the Patents and Inventions disclosed therein and all associated rights in this or any foreign country including any additional documents needed to record and fully effect the transfer of patent rights made herein in the United States or any foreign country. If for any reason Assignee is unable, after reasonable effort, to secure Assignor's signature on any document needed to procure or perfect Assignee's interest in any of the Patents and Inventions, Assignor hereby appoint Assignee as its attorney in fact with full power of substitution on behalf of Assignor and for the benefit of Assignee, to execute and enter into any documentation relating to the Patents and Inventions, to secure recordation or registration of the Patents and Inventions, and to Secure recordation or registration of this assignment.

4. Governing Law. This Patent Assignment shall be exclusively governed by and construed in accordance with the laws of the State of New York without regard to principles of conflicts of law.

5. Counterparts. This Patent Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

6. Entire Agreement. This Patent Assignment, together with all exhibits and schedules hereto constitute the entire agreement of the parties hereto with respect to the subject matter hereof and supersedes all prior agreements and undertakings, both written and oral, among the parties hereto with respect to the subject matter hereof.
