RELEASE OF SECURITY INTEREST

This Release of Security Interest is made effective as of October 1, 2013 (this "Release"), by Decathlon Alpha, L.P. ("Lender") in favor of SENDMAIL, INC., a Delaware corporation ("Company") with its principal place of business located at 6475 Christie Avenue, Suite 350, Emeryville, CA 94608.

RECITAL

WHEREAS Company and Lender entered into a Subordinated Revenue Loan and Security Agreement dated as of July 10, 2012 and subsequently amended on January 31, 2013 (as amended, the "Agreement").

WHEREAS, in connection with the Agreement, Company granted to Lender a security interest in the patents and trademarks set forth on Exhibits A and B, respectively, attached hereto (collectively, the "Intellectual Property") under an Intellectual Property Security Agreement dated as of July 10, 2012 (the "Security Agreement") and recorded with the U.S. Patent and Trademark Office in the trademark assignments branch on August 16, 2012 at Reel/Frame 4849/0315.

WHEREAS, in accordance with that certain payoff letter dated as of October 1, 2013 from Decathlon to Sendmail, Company has no outstanding obligations to Lender under the Loan Agreement or under the Security Agreement, and therefore Lender agrees to release its security interest in the Intellectual Property.

WHEREAS Lender has authorized Company to prepare and sign this Release on its behalf.


AGREEMENT
