

Between:

- (1) **Lars Seved Wallin**, a Swedish citizen, of 60 Rotary Way, Colchester, CO3 3LG (the "Assignor"); and
- (2) **ARLINGTON TECHNOLOGY HOLDINGS LIMITED** incorporated and registered in England and Wales with company number whose registered office is at 34 Arlington Road, London, NW1 7HU (the "Assignee"). ⁷³²⁵⁷⁹⁴ 

Whereas:

- (A) The Assignor is the legal and beneficial owner of the invention entitled Digital Asset Authentication System and Method as described in the specification included in the attached Schedule and as identified in the books of the Company and of the Company's patent attorneys as Case No: P48879GB and P50713GB and registered patent number GB1005733.9 and GB1019390.2 (the "Invention").
- (B) The Assignor has agreed to assign all of its right and interest in and to the Invention and all its rights attaching thereto to the Assignee for the consideration mentioned below.

It is agreed as follows:

1 Assignment

- 1.1 In consideration of ten pounds sterling (£10) (the receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee absolutely and with full title guarantee the Invention and all the rights powers and liberties and immunities conferred on the proprietor by the filing of applications for patents or other intellectual property rights and the grant of patents or other intellectual property rights for the invention including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of any published specification of any patent or accompanying application therefor TO HOLD the same unto the Assignee absolutely.
- 1.2 The Assignor hereby agrees that he will at the request of the Assignee execute and sign all such documents or do any such acts as may be necessary or desirable to give full effect to this Assignment and to record the Assignee as proprietor of the invention or of any application for a patent or any other intellectual property rights for the invention. The Assignee will reimburse all reasonable out of pocket expense of the Assignee in executing and signing such documents and doing such acts.

2 Law and Jurisdiction

- 2.1 This Assignment shall be governed by and construed in accordance with English law.
- 2.2 All parties irrevocably agree that the Courts of England are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this Agreement. All parties irrevocably submit to the jurisdiction of such courts and waive any objection to proceedings in any such court on the ground of venue or on the ground that the proceedings have been brought in an inconvenient forum.


