AND WE HEREBY, as the above named inventors, declare that we believe that we are the original inventors of a claimed invention in the above-identified application;



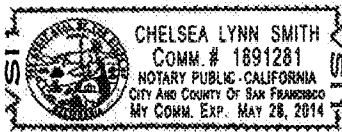
years, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
