AMENDMENT OF CHARTER

This Instrument Witnesseth That the Board of Regents for and on behalf of the Education Department of the State of New York at their meeting of October 19, 2010,

An application having been made by and on behalf of the trustees of Mount Sinai School of Medicine of New York University, for an amendment of its charter, it was

Voted, that the provisional charter of Mount Sinai School of Medicine of New York University, located in the city, county, and state of New York, which was granted by action of the Board of Regents under the corporate name "Mount Sinai Hospital School of Medicine" on June 28, 1963; which provisional charter was amended by Regents action on December 18, 1964 to change the corporate name to "Mount Sinai School of Medicine," October 28, 1966 and October 27, 1967 to change the corporate name to "Mount Sinai School of Medicine of the City University of New York" and was made absolute by Regents action on May 24, 1968; which absolute charter was amended by Regents action on December 19, 1969, November 15, 1990, and on July 17, 1998 which, among other things, changed the corporate name, effective July 1, 1999, to "Mount Sinai School of Medicine of New York University," and on February 3, 1999 be, and the same hereby is, amended, effective November 18, 2010, to change the corporate name to "Mount Sinai School of Medicine"; and to authorize the institution to terminate its academic affiliation with New York University, make its own faculty appointments, and operate postsecondary degree programs registered by the State Education Department and confer degrees approved and authorized by the Regents in connection with such programs.
