ASSIGNMENT



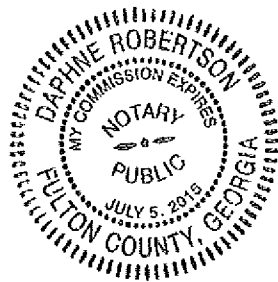

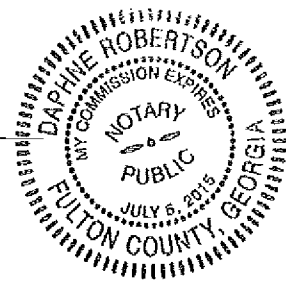
