ASSIGNMENT OF PATENT

This Assignment of Patent (the "Assignment") is made and effective as of June 4, 2012 ("Effective Date") by and between Public Display, Inc., a corporation duly organized in the state of Delaware with registered offices at 150 Chestnut Street, Providence, Rhode Island 02903 and Ground Floor, LLC, a limited liability company duly organized in the state of Delaware with offices at 955 Fort Getty Road, Jamestown, Rhode Island 02835 (collectively, the "Assignors") and Vadim Hunte, an individual residing at 4895 Ashley Lane, Apartment 310, Inver Grove Heights, MN 55077 and Ganesh Peruvemba, an individual residing at 4400 College Park Drive, Apt #728, Conroe, TX 77384 (collectively, the "Assignees"). The Assignor and the Assignees may be referred to individually as a "Party" or collectively as the "Parties."

RECITALS

WHEREAS, Public Display, Inc. is the owner of record regarding certain patent rights arising out of and related to US Patent No. 7,577,963 B2, filed with the United States Patent and Trademark Office on August 18, 2009 (the "Patent");

WHEREAS, Ground Floor, LLC has acquired all of the assets of Public Display, Inc., including but not limited the Patent;

WHEREAS, the Assignees desire to acquire all of the Assignors' right, title, and interest in and to the Patent and any and all letters patent or similar legal protections, foreign or domestic, to be obtained therefor; and

WHEREAS, Assignors and Assignees have entered into a Patent Purchase and Sale Agreement for US Patent No. 7,577,963 B2 dated the 4th day of June, 2012 ("Purchase and Sale Agreement") wherein Assignors have agreed to sell and Assignees have agreed to purchase the Patent.

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration to Assignor, the receipt of which is hereby acknowledged, Assignors sell, transfer, convey, assign, and deliver to the Assignees, and the Assignees accept, jointly and severally, and assume all of the Sellers' right, title, and interest in and to the following:

- (a) the Patent;
- (b) the patent claims, all rights to prepare derivative works, all goodwill, and other rights to the Patent;
- (c) any and all registrations, applications (including any divisions, continuations, continuations-in-part, and reissues of such applications), corresponding domestic and foreign applications, letters patents, or similar legal protections issuing on the Patent, and all rights and benefits under any applicable treaty or convention;
- (d) all income, royalties, and damages hereafter due or payable to the Seller with respect to the Patent including, without limitation, damages and payments for past or future infringements of the Patent; and
- (e) all rights to sue for past, present, and future infringements of the Patent.

AUTHORIZATION TO DIRECTOR

The Assignors hereby authorize the Director of the United States Patent & Trademark Office to assign the Patent to the Assignees, joint and severally, of the entire right, title, and interest in and to the same, for the Assignees sole use and for the use of the Assignees' legal representatives, to the full end of the term for which said Patent may be granted, as fully and entirely as the same would have been held by the Assignors had this assignment and sale not been made.


