- (b) The Assignor will, as may be required by the relevant legislation from time to time, issue a certificate ("Tax Invoice") to the Assignee in respect of the GST.
- (c) Within seven days of receipt of the Tax Invoice, the Assignee will pay to the Assignor the amount of the GST identified in the Tax Invoice.


