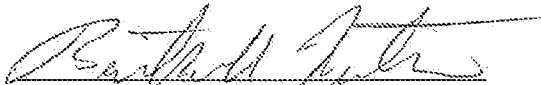

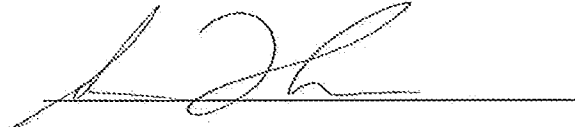
This Assignment Agreement is effective as of December 18, 2009.

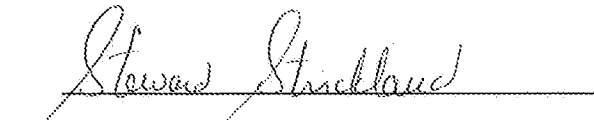

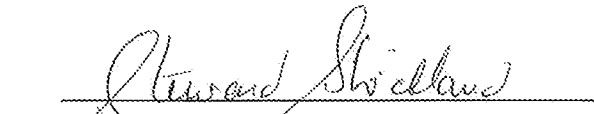

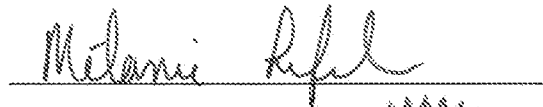
