U.S. PATENTS RELEASE OF SECURITY INTEREST**

THIS RELEASE dated as of November 26, 2013, by UBS AG, STAMFORD BRANCH, as Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Term Loan Agreement referred to below.

A. Reference is made to the Amended and Restated Second Lien Term Loan Agreement dated as of October 23, 2012 (the "*Term Loan Agreement*"), among FR BRAND HOLDINGS CORP., a Delaware corporation, BRAND ENERGY & INFRASTRUCTURE SERVICES, INC., a Delaware corporation (collectively, the "*Borrowers*"), the LENDERS party thereto and UBS AG, STAMFORD BRANCH, as agent (in such capacity, the "*Agent*") for the Lenders.

B. Reference is made to (i) the Amended and Restated Guarantee and Collateral Agreement, dated as of October 23, 2012 (the "*Guarantee and Collateral Agreement*"), among FR BRAND HOLDINGS CORP., BRAND ENERGY & INFRASTRUCTURE SERVICES, INC., the Subsidiary Guarantors (as defined in the Guarantee and Collateral Agreement), and UBS AG, STAMFORD BRANCH, as collateral agent for the Second Lien Secured Parties (as defined in the Guarantee and Collateral Agreement), and (ii) the Second Lien Patent Security Agreement, dated as of October 23, 2012 (the "*Security Agreement*" and, collectively with the Term Loan Agreement and the Guarantee and Collateral Agreement, the "*Security Documents*"), among the Grantors (as defined in the Security Agreement) in favor of the Agent, pursuant to which Guarantee and Collateral Agreement and Security Agreement, among other things, each Grantor granted a security interest to the Agent, for the benefit of certain secured parties named therein, in personal property of such Grantor, including all right, title and interest of such Grantor in, to and under the Patent Collateral (as defined in the Security Agreement), including without limitation, those registered patents and pending patent applications set forth on Schedule A hereto, which security interest was recorded with the United States Patent & Trademark Office on October 24, 2012 on Reel 029187 Frame 0878.


C. In connection with the termination of the Term Loan Agreement, the Borrowers have informed the Agent of their desire to obtain the release of all right, title and interest of the Agent, the Lenders and each other grantee or beneficiary in and to the Patent Collateral granted under the Security Documents.


Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, releases and discharges all of its right, title and interest (including, without

limitation, security interests) in and to the Patent Collateral (including, without limitation, the registered patents and pending patent applications set forth on Schedule A attached hereto) pursuant to the Security Documents, the debt secured thereby having been paid and satisfied in full. Any right, title or interest of the Agent in the Patent Collateral under the Security Documents shall hereby cease and become void.
