EXCLUSIVE LICENSE AGREEMENT

THIS EXCLUSIVE LICENSE AGREEMENT ("License Agreement"), dated as of May 20, 2011 (the "Effective Date"), by and between **AGS, LLC**, a Delaware limited liability company with a place of business located at 2470 Saint Rose Parkway, Suite 210, Henderson, NV 89074 ("AGS"), and both **Game Ingenuity, LLC**, a Nevada limited liability company with a place of business at 3003 Red Arrow Dr., Las Vegas, Nevada 89135 ("GI") and **Olaf Vancura**, an individual with an address of 3003 Red Arrow Dr., Las Vegas, Nevada 89135 ("Vancura") (collectively "GI/Vancura").

WHEREAS, AGS and GI/Vancura have previously entered into an Exclusive Distribution Agreement executed November 23, 2010 ("Distribution Agreement") and Employment Agreement dated October 15, 2010 ("Employment Agreement"), both of which will remain separate and apart from this License Agreement;




WHEREAS, GI/Vancura is the owner of all right, title and interest in and to certain intellectual property rights in the field of Gaming Products including certain issued patents, pending patent applications, and pending provisional patent applications owned by GI/Vancura as set forth on Schedule 1 attached hereto, which Schedule will be updated from time to time, including as patent applications are filed and patents are issued;

1.11 "Licensed GI/Vancura Intellectual Property Rights" shall mean the GI/Vancura United States Patent Rights, any GI/Vancura Foreign Patent Rights, the GI/Vancura Licensing Rights and any Documented Intellectual Property approved (either herein or hereafter) by an internal patent committee at AGS.

1.12 "GI/Vancura United States Patent Rights" shall mean the rights to any issued United States patents, any United States provisional patent applications, any pending United States patent applications, including all continuations, continuations-in-part, improvements and divisional applications thereof, any patents issuing on or claiming priority to any of the foregoing and all reissues, reexaminations or extensions of any of the foregoing, pending or issued as of the Effective Date, relating to Gaming Products including but not limited to the list of the same set forth in Schedule 1.

2.2 **Grant of License.** Subject to the terms and conditions of this License Agreement and the Employment Agreement, GI/Vancura hereby grants to AGS an exclusive, worldwide, royalty-bearing, irrevocable, license to make, have made, copy, modify, make derivative works of, and use the Licensed GI/Vancura Intellectual Property Rights and GI/Vancura Technical Know-How as part of or in connection with one or more Licensed Gaming Products.
