WHEREAS, Changho LEE, Seungho BAEK and Jooah KIM hereinafter called the "Assignors", have made the invention described in the United States patent application entitled **STEREOSCOPIC IMAGE DISPLAY AND METHOD OF DRIVING THE SAME**, executed by Assignors on the same date as this Assignment;

WHEREAS, LG DISPLAY CO., LTD. a corporation organized and existing under the laws of Korea, having a place of business at 128, Yeoui-daero, Yeongdeungpo-gu, Seoul, 150-721, Republic of Korea, hereinafter called the "Assignee," desires to acquire the entire right, title and interest in and to the invention and the patent application identified above, and all patents which may be obtained for said invention, as set forth below;
