ASSIGNMENT

AND ASSIGNOR covenants and agrees that s(he) will communicate to the said ASSIGNEE, its successors, legal representatives and assignees, any facts known to the said ASSIGNOR respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
