2. Authorizes Assignee to file patent applications and nationalizations of the above-identified applications in any or all countries except the United States of America on any or all of said inventions and discoveries in the name of the Assignor, the names of the inventors, or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;



Binds the Assignor's successors, assigns, and legal representatives, as well as the Assignor, to do, upon Assignee's request and at its expense, but without additional consideration to Assignor or them, all acts reasonably serving to assure that the said inventions and discoveries, the said patent application and the said patents that issue from applications filed by Assignee shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor or by Assignor's successors, assigns, or legal representatives if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to Assignor relating to said inventions and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in our control or in the control of Assignor's successors, assigns, or legal representatives and which may be useful for establishing the facts of conceptions, disclosures, and reductions to practice to said inventions and discoveries.
