ASSIGNMENT

Whereas, **Michael KRASNICKI**, an individual, with an address of 5404 Galahad Lane, Richardson, Texas, 75082, and **Yue DENG**, an individual, with an address of 801 Legacy Drive, #1921, Plano, Texas, 75023, ("Assignors"), have invented certain new and useful improvements in a METHOD AND SYSTEM OF CHANGE EVALUATION OF AN ELECTRONIC DESIGN FOR VERIFICATION CONFIRMATION (the "Invention"), for which United States Patent Application was filed on June 27, 2013 (Serial No. 13/929,007) (the "Application"); and

Whereas, **Zipalog, Inc.**, a Delaware corporation located at 850 Central Parkway East, Suite 160, Plano, Texas, 75074 ("Assignee"), is desirous of acquiring the entire right, title, and interest in the Application.

This invention was made with Government support under IIP-1215450 awarded by the National Science Foundation. The government has certain rights in this invention.

Assignors hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for the Invention, or patents resulting therefrom, insofar as Assignors' interests are concerned, to Assignee, of the entire right, title, and interest in and to the same, for its sole use and benefit; and for the use and benefit of its legal representatives, to the full end of the term for which said Patent(s) may be granted, as fully and entirely as the same would have been held by the Assignors had this assignment not been made.

Assignors also sell and assign to Assignee, its successors, assigns and legal representatives the full and exclusive right, title, and interest to the Invention disclosed in said Application throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for the Invention in the Assignee's own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of the Invention and all rights to register the Invention in appropriate registries, all foreign rights arising from pre-grant publication of the Application; and Assignors further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.

Assignors further agree to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Invention in all countries.

Assignors further authorize and direct Assignee's attorneys to insert the serial number and filing date of said application now identified by the attorney docket number and title set forth above as soon as the same shall have been made known to them by the United States Patent and Trademark Office.

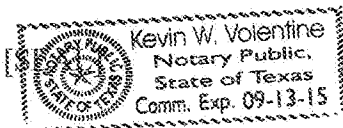

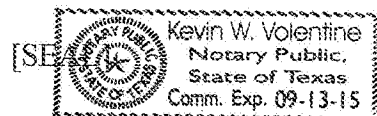
