(a) but are owned by Assignor (collectively, the "Purchased IP"); together with all national, foreign, state and common law rights, registrations and applications, all goodwill, and all benefits, privileges, causes of action and remedies relating to any of Purchased IP, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain any registrations, extensions, divisions, reissues, substitutes, renewals and/or continuations thereof, to sue for all past, present or future infringements or other violations of any rights in such Purchased IP and to settle and retain proceeds from any such actions). Without limiting the generality of the foregoing, with respect to any patent applications that are included in the Purchased IP and/or related to the Kit Digital Platform already filed or to be filed in the future, Assignor hereby assigns, transfers and conveys to Assignee and Assignee's successors and assigns, all of its right, title and interest throughout the world in and to all patent, utility models, inventor's certificates and design rights now or hereafter granted in the United States law, the International Convention for the Protection of Industrial Property and the Patent Cooperation Treaty.

2. Further Cooperation. As and to the extent provided in the Purchase Agreement, Assignor shall execute such written instruments (at the expense of Assignor or Assignee, as provided in the Purchase Agreement) extend such other cooperation and perform such other acts as may be reasonably necessary or advisable to more effectively transfer, assign to and vest in Assignee the Purchased IP and all right, title and interest thereto (including, without limitation, by making and executing any and all required copyright, patent, or trade secret assignments, certificates, applications or other documents requested by Assignee, its successors or assigns, including without

limitation, each of the assignment documents attached hereto as Exhibit A) and Assignor hereby irrevocably appoints Assignee and any of its officers as its attorney in fact to undertake such acts in its name. Assignor also agrees, upon the reasonable request of Assignee, to provide production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, powers of attorney, specifications, declarations or other papers and other assistance reasonably necessary for filing and/or prosecuting patent applications, complying with any duty of disclosure, and conducting prosecution, reexamination, reissue, interference, or other priority proceedings, opposition proceedings, cancellation proceedings, public use proceedings, infringement or other court actions and the like with respect to the Purchased IP.
