RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE, dated as of November 14, 2013 (the "Effective Date"), is made by PIVOTAL INVESTMENT PARTNERS I, L.P., a Delaware limited partnership ("Pivotal").

WHEREAS, pursuant to the Patent Security Agreement (the "Patent Security Agreement"), dated as of February 19, 2010, Soil and Topography Information, LLC ("STI LLC") granted to Pivotal a continuing first priority security interest in and to STI LLC's entire right title and interest in, to and under the following, whether presently owned or subsequently acquired or created (all of which shall collectively be called the "Collateral"):

(a) inventions or improvements disclosed in the applications for Letters Patents of the United States and other countries presently filed, as more particularly described in Schedule A attached hereto and made a part hereof, and all other applications both United States and foreign on said inventions or improvements and on any subsequent inventions and improvements disclosed in any applications for Letters Patent of the United States and other countries herein after in all cases including divisional, continuation, continuation-in-part and substitute applications regardless of whether said other applications are based upon the applications described on Schedule A in whole or in part and in any and all Letters Patent of the United States and foreign countries which may be obtained on any of such applications and in any reissue or extension of such patents ("Patents");

(b) all of STI LLC's rights under all patent applications including but not limited to the registrations and applications listed in Schedule A;

(c) all of STI LLC's right to payment of all monetary obligations resulting from or arising out of any Patents;

(d) all of STI LLC's rights under all license royalty, and other agreements with respect to any Patents;

(e) all tangible and electronic property embodying or incorporating any Patent owned or controlled by STI LLC;

(f) all claims, actions, proceedings, damages, liabilities, and expenses of every kind that STI LLC has against or is able to recover from any person whether known or unknown resulting from or arising out of the person's infringement of any copyright, patent or trademark misappropriation of any trade secret or violation of any other intellectual or proprietary right of STI LLC with respect to any Patent;

(g) all proceeds of any of the above property; and

(h) books of account and records related to any of the above property.

WHEREAS, in connection with the Patent Security Agreement, STI LLC assigned its rights in certain patents to Pivotal with such assignment to be effective as of the date of an "Event of Default" under the Patent Security Agreement ("**Patent Assignment**");

WHEREAS, STI LLC, with Pivotal's consent, converted into Soil and Topography Information, Inc., a Delaware corporation ("**STI**") on October 18, 2010;

WHEREAS, STI defaulted on the loan secured by the Patent Security Agreement and, with Pivotal's consent, STI assigned its rights in all of its assets (including its rights in the Patents) to Soil Data, LLC, an Oregon limited liability company ("**Soil Data**"), pursuant to that certain Assignment in Lieu of Foreclosure and that certain Copyright Assignment in Lieu of Foreclosure, both dated September 13, 2012;

WHEREAS on September 12, 2012, STI, with Pivotal's consent, assigned its rights in the License Agreement between STI and C3 Consulting LLC, a Wisconsin limited liability company ("**C3**"), to Soil Data pursuant to that certain "Notice of Assignment of License Agreement dated July 1, 2012";

WHEREAS on October 8, 2012, Pivotal filed the Patent Assignment with the United States Patent and Trademark Office; and,


WHEREAS, pursuant to that certain Intellectual Property Transfer Agreement between Pivotal and C3 dated as of the Effective Date, Pivotal has agreed to terminate the liens and security interest created under the Patent Security Agreement and has agreed to provide a document suitable for recording evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral (the "**Released Collateral**").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Pivotal does hereby, (i) terminate the liens and security interest created under the Patent Security Agreement in the Released Collateral, (ii) release its security interest in the Released Collateral, and (iii) discharge any and all rights, title and interest it has in and the security interest granted to Pivotal in the Released Collateral. Pivotal acknowledges that this Release may be filed along with other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein. Pivotal will execute such further documents as deemed reasonably necessary by C3 to confirm and effect this Release.
