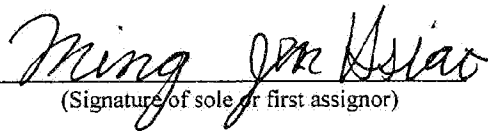
ASSIGNMENT DEED
