

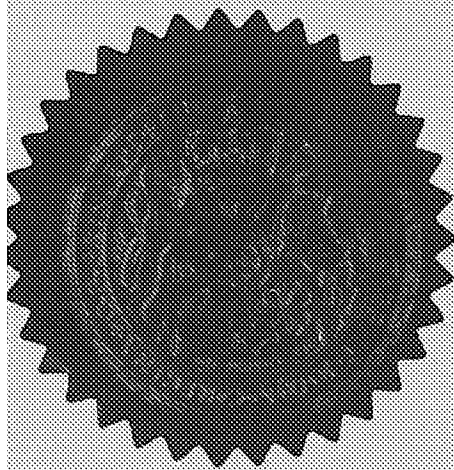

SCHEDULE

AMENDMENTS TO THE CHARTER OF QUEEN MARY AND WESTFIELD COLLEGE,
UNIVERSITY OF LONDON

1. In Article 1:
 - a) after "Queen Mary" *delete* "and Westfield College,";
 - b) after "referred to as" *delete* "the College" and *substitute* "QMUL and previously named Queen Mary and Westfield College, University of London from 1989 to 2013".
2. Wherever it occurs in the Charter *delete* "the College" and *substitute* "QMUL".
3. In Article 3 *delete* "and Statutes".
4. In Article 10(a) *delete* the second iteration of "four years".
