C, 26250 Livron Sur Drome, France, **Christian DUCLOT**, a citizen of France residing at Résidence Belair, 6 avenue Ferdinand Janvier, 07100 Annonay, France, and **Wilfrid BEAUGRAND**, a citizen of France residing at 35 rue Basses Crozettes, 26000 Valence, France hereby sell, assign and transfer to **SOLYSTIC**, an organization duly organized and existing under the laws of France, and having a principal place of business at 152-160 avenue Aristide Briand, 92220 Bagneux, France, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in **A STACKER DEVICE FOR STACKING FLATS, A STORAGE DEVICE FOR STORING POSTAL FLATS, AND A POSTAL SORTING MACHINE**, which is described in PCT International Patent Application No. **PCT/FR2013/052042** filed on **September 5, 2013**, which was transmitted to the United States Patent and Trademark Office by the International Bureau, for which commencement of the national stage in the U.S.A. is sought, in furtherance of which a Declaration in accordance with 35 U.S.C. 371 is executed by us on even date herewith; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We request that any and all patents for said inventions in all countries be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.






it; and to invoke and claim such right of priority without further written or oral authorization from us.
