

KG, its successors, assigns, nominees or other legal representatives, all facts known to me respecting said invention, whenever requested, and testify in any legal proceedings, sign all lawful papers, execute and deliver all divisional, continuing and reissue applications, make all rightful oaths and do all lawful acts requisite for the application for such divisional, continuing or reissue applications, or the procuring thereof, and that if and when said Horst Heydasch Dummy Block GmbH & Co. KG, its successors, assigns, nominees or other legal representatives desire to file a disclaimer relating thereto, I will upon request, sign and deliver all lawful papers requisite for the filing of such disclaimer, and I further covenant and agree that I will, at any time upon request, do everything legally possible to aid said Horst Heydasch Dummy Block GmbH & Co. KG, its successors, assigns, nominees or other legal representatives, either in its or my own name, to apply for, obtain and enforce proper patent protection in all countries, including priority rights granted to patents in foreign countries according to all the laws and treaties in force, all without further consideration but at the expense of said Horst Heydasch Dummy Block GmbH & Co. KG, its successors, assigns, nominees or other legal representatives.
