ASSIGNMENT



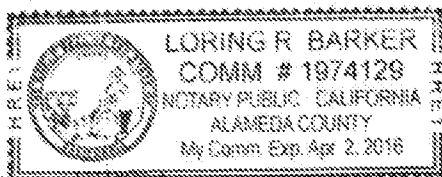
