ASSIGNMENT

WHEREAS, we, Peter Birke, Reinhard Geyer, Jurgen Hunold, Peter Kraak and Rainer Schoedel, have made a certain improvement in CATALYST FOR THE HYDROGENATION OF UNSATURATED HYDROCARBONS AND PROCESS FOR ITS PREPARATION for which application papers for United States Patent thereon, identified as TS9515-US-DIV, have been executed by us, and,

With respect to any country where for the filing of such an application and/or the transfer of priority rights a separate deed of sale, assignment or transfer is required, we will undertake at the request of SHELL OIL COMPANY to execute such separate deed to SHELL OIL COMPANY or to whomsoever that company may nominate.


