- (D) The Invention has been made by GORDON ROBERTSON during a period of employment with M SQUARED LASERS and in the course of his normal duties with M SQUARED LASERS and by virtue of the terms of his employment with M SQUARED LASERS the Invention is to be taken as between M SQUARED LASERS and GORDON ROBERTSON to belong to M SQUARED LASERS as his employer.

NOW THIS AGREEMENT WITNESSES as follows:-


