ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
CLOUDVU, INC.

Pursuant to the provisions of the Utah Revised Business Corporation Act (the "Act"), the undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is CloudVu, Inc.

SECOND: The following amendment to the Articles of Incorporation was duly consented to and adopted by written consent of the shareholders of the Corporation on August 30, 2013 in the manner prescribed by the Act. The holders of the Corporation's (i) common shares, no par value (the "Common Stock"), (ii) Series A Convertible Preferred Stock, no par value (the "Series A Stock"), (iii) Series B Convertible Preferred Stock, no par value (the "Series B Stock"), and (iv) Series C Convertible Preferred Stock, no par value (the "Series C Stock") voted together as a single class on an as-converted basis.

THIRD: Article I of the Articles of Incorporation is deleted in its entirety and replaced with the following:

"ARTICLE I

The name of this corporation is PurePredictive, Inc."
