ASSIGNMENT

WHEREAS, we, **GHOLAMREZA CHAJI** and **AROKIA NATHAN**, have invented certain new and useful improvements in the following: **"STABLE FAST PROGRAMMING SCHEME FOR DISPLAYS,"** for which we have made an application for United States Letters Patent; and

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

We hereby further agree that we will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns, and legal representatives to obtain and enforce proper protection for said invention in all countries.

We further authorize and direct the ASSIGNEE's attorneys to insert below* the serial number and filing date of said application now identified as Docket No. 058161-000043USPT as soon as the same shall have been made known to them by the United States Patent Office.


