NOW THIS DEED WITNESSES AND IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. That in consideration of the sum of Re.1 paid by the Assignee to each of the Assignors (the receipt whereof the Assignors hereby acknowledge) as well in consideration of the contract of employment between each of the Assignors and the Assignee, the Assignors as the sole and beneficial owners, hereby grant, transfer and assign unto the Assignee their invention and all rights, title, interest, benefits, privileges, advantages and goodwill associated with the Invention and to hold the same absolutely including the right to apply and hold the Patent or similar protection for the invention in any part of the world and all the Assignor's rights, title, interest, benefits, privileges, advantages thereof including but not limited to:

2. That the Assignors further covenants that the Assignors shall sign all necessary deeds / documents in connection with the assignment of the intellectual property rights as regards to the Patent in favour of the Assignee and do all acts as may be required for giving effect to this Assignment.
3. That the Assignors have not assigned or otherwise dealt with the invention. The Assignors further covenants that nothing has been done to prejudice the rights of the Assignee as transferees of the invention / Patent and the Assignee is entitled to its exclusive use or license the same.
4. That, if at any time while the said Patent / Patent application is in force, or any other corresponding patent / patent application on the same or substantially same subject-matter, the Assignors discover, invent or make any improvement or improvements upon the Invention, the same shall be disclosed to the Assignee. The Assignors shall also do all other acts and execute all such deeds as may be necessary for assigning / vesting in the Assignee, all rights, title and interest in the such further improvements and the full benefits thereof. Further, the Assignors hereby undertake to enable the Assignee to make practical use of the Invention as well as such further improvements.





