AND the Assignors hereby confirm that the Assignee has filed US patent application for said improvements on July 24, 2011 to which serial No. 61/511,092 has been assigned, US patent application for said improvements on November 29, 2011 to which serial No. 61/564,513 has been assigned, US patent application for said improvements on December 30, 2011 to which serial No. 61/581,950 has been assigned and US patent application for said improvements on February 1, 2012 to which serial No. 61/593,533 has been assigned, and is entitled to file any US patent applications based on said improvements;

AND for the same consideration, the Assignors hereby covenant to and agree with the Assignee, its successors and legal representatives, that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of their entire right, title, and interest in and to the improvements set forth in said above-mentioned application, and that the same right, title, and interest are unencumbered, and that the Assignors have good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND for the same consideration, the Assignors hereby covenant to and agree with the Assignee, its successors, and legal representatives that the Assignor will, whenever
