any legal proceedings and perform all other lawful acts deemed necessary or desirable by said ASSIGNEES, their successors, legal representatives or assigns, to perfect title to said Patents in the United States and foreign countries, and to assist Assignees and their successors, legal representatives or assigns in obtaining, reissuing or enforcing the Patents.

Assignor further grants the firm of Philip G. Meyers Intellectual Property Law, P.C., the power to insert in this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and trademark Office for recordation of this Assignment.

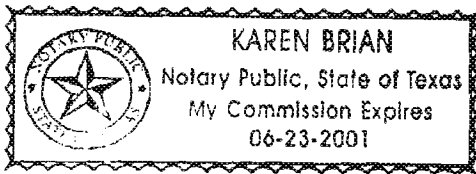
